AN ORDINANCE OF THE TOWN OF TRAIL CREEK, INDIANA AMENDING CHAPTER 26 OF THE TOWN CODE:

WHEREFORE the Town of Trail Creek Town Council is responsible for maintaining the Building Code and Building Permits for the Town of Trail Creek, Indiana, and

WHEREFORE the Town of Trail Creek, Indiana, Town "Council" is responsible for reviewing and updating the permit fees for the Town on a regular basis.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Trail Creek, Indiana that:

Section 26-10 of the Town of Trail Creek, Indiana Code be deleted and substituted therefore as the following:

<u>Chapter 26 – 10</u>

- (1) Building permits (section 10-26)
 - (a) New Construction/Replacement

Local Businesses and General Office Construction 350.00

The above is predicated on the Building Inspectors Inspections of the structure 7 times. If additional inspections are necessary the inspection cost is \$50.00 for each additional Inspection at the discretion of the Inspector.

(b) Electrical, Plumbing, Mechanical – HVAC permit fees

(1) The electrical, plumbing, mechanical/HVAC permit fees shall be \$50.00 per inspection as required by the Building Code.

Chapter 26-10(2) If the number of inspections exceed the original number required by the inspector because of failure of an inspection, the inspector has the power to charge \$50.00 for each additional inspection.

Chapter 26-10(3) Permit Fees Generally:

No refunds shall be allowed for permits already issued and monies that have been collected for such permits.

Each permit issued shall incur a \$5.00 Administration fee paid to the Clerk in an appropriate Town Fund for administrative expenses.

Chapter 26-10(4) Driveway/Improvement or Construction

Permit Fee within Town Right of Way/Easement
Predicted in Two Inspections \$100.00
If additional Inspections are required = \$50.00 for each inspection.
